### **RULES** (please read carefully)

- ❖ For Food Vendors: All City of Canton Health Permits must be displayed. You must obtain a Special Events food permit from the City of Canton 201 N. Buffalo St. Canton, TX 75103
- Vendor may bring canopy with weighted anchors (no staking in pavement), banner, tables, chairs and extension cords (all must fit within booth space)
- Vendors are responsible for their own setup & tear down, their booth at all times, and collection and payment of state sales tax (when applicable). A copy of the Sales Tax Certificate must be supplied with this application.
- Sharing of vendor space is not allowed, unless approved.
- No sale of lewd / inappropriate merchandise. This is a family festival.
- ❖ VENDOR SET-UP: Saturday from 7:00 a.m. until 10:00 a.m. No vehicles will be allowed into the festival area after 9:30 a.m. ALL vehicles must be out of festival area by 9:30 a.m. ready to sell by 10:00 a.m.
- **❖** BREAKDOWN: 5 PM No one will be allowed to break down before 5:00 p.m. Any vendor breaking down before 5 PM will not be allowed to return to the Autumn Festival for one year.
- Understand there is NO REFUND neither for cancellation due to inclement weather nor COVID 19 reasons. The vendor space fee is utilized to offset event production costs (sound, entertainment, event supplies and etc.).

**WHERE:** Downtown Canton, TX – North and South Buffalo Street, and around Courthouse Square. In case of rain, the festival will be moved to covered areas on the First Monday Grounds. Any change will be announced after 6 P. M. on Wednesday, October 11, 2022.

**PROMOTION:** Canton Main Street Autumn Festival will be promoted throughout Texas with additional exposure through local and regional radio, magazines, newspapers, websites, **Facebook @ Canton Main Street Autumn Festival and Canton TX Main St Program,** posters & flyers.
